





# Research Assistant/Lab Manager

The position is funded by the NAWA Polish Returns programme, full-time, for 36 months (initial contract will be signed for 12 months and then extended until the end of the project).

- Support day-to-day lab operation and lab maintenance: ordering/inventorying reagents and lab supplies, keeping general lab documentation up to date, mediate interactions with in-house facilities and services, maintaining stock solutions and buffers
- Assists in **grant administration**: communication with university bodies and grant agencies
- Involvement in **specific lab projects** and conducting molecular biology and cell culture experiments (including basic methods, such as qRT-PCR, genotyping, cloning as well as assistance in generating new cellular models using CRISPR/Cas9 or in functional genomics methods)
