11. Questions posed to the PhD student (both at the first and second stage of the mid-term evaluation):

Dr Przemysław Janikowski: What maximum range of co-occurrences of "assault" and "abuse", the distance for words, did you use? Did you or are you planning to manually test the co-occurrences, even if they do occur, is it in the context of "incest"?

Prof. Iwona Witczak-Plisiecka: I wanted to ask you whether absence has been a problem so far? Has linguistic absence been a problem in your corpus, not only in a quantitative but also in a subject matter analysis?

Prof. Bożena Cetnarowska: It is not a question, but a comment. Because you have mentioned the absence of some vocabulary in your corpus related to incest. The difficulty to find its equivalents. I have read about the 16th-17th-18th-century Lithuania and Russia, there was a term which meant "the right of the father-in-law to maintain sexual relations with his daughter-in-law", and that was called *snochactwo*. And it also shows that if you have a term to name something, it means that this culture allows it. And in the case of taboo language, certain concepts either are not given a name or are avoided. By the way, would it count as incest?

Prof. Andrzej Łyda, addressing Sohie: You introduce your understanding of taboo language, not as a kind of forbidden language, but language for talking about taboo. Somewhere in your first chapter, you write about the three sort of universal prohibitions: do not murder people, do not eat human flesh, and do not sleep with your daughter. I find it a very interesting and innovative approach. What led you to such a differentiation? Is incest different from rape which we simply call rape? And from murder which we simply call murder? Why don't we call incest incest?

Prof. Maria Giovanna Fusco: My question would be about the difference, if you specify that between incest and child abuse which involves incest, because you might have incest between consenting adults, which would be a completely different category. I guess your corpus focusses on minors.

Prof. Ewa Bogdanowska-Jakubowska: You have written that you intend to start a discussion on incest to promote better child protection. I assume that you plan to follow a critical approach to discourse analysis. Could you elaborate on the methodology employed in the investigation of incest as a social issue?

- 15. Detailed justification of the Commission on the result of the mid-term evaluation (justify the result in detail; under the Act of 20 July 2018. Sophie Eysette has presented a clear and ambitious research plan, based on her own corpus. The realization of the project may turn out to be important not only for the research on taboo language and incest, both as a linguistic and social issue, but also for corpus linguistics. She has written three chapters of her dissertation. Her Individual Research Plan is being realized according to the schedule.

Her academic activity is impressive. She has written two articles: one has been accepted for publication, the other is being reviewed. She has presented eight papers during conferences. She has participated in workshops aimed at broadening the knowledge and improving skills useful in corpus linguistic research.

The evaluation committee has unanimously voted for the positive evaluation of Sophie Eysette's progress in the preparation of the doctoral dissertation and her research activity, and expressed hope that the doctoral dissertation would be submitted on time.

The evaluation committee stresses her great intellectual potential and commitment to academic research.
