3. The purposes of the processing and the legal basis for the processing

Your personal data will be published pursuant to Article 6(1) point a, c, e and f or to Article 9(2) point a of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation):

- your freely given consent to the processing of personal data for the purpose of recruitment to the project.

Provision of personal data is a prerequisite for carrying out of the process and handling students' and doctoral students' matters. Should you decline to submit your personal data, we will not be able to achieve the objective specified above.

4. The period of storage of personal data

5. The recipients of the personal data

Your personal data may be transferred to the processors on our behalf and bodies or public authorities entitled to obtain data on the basis of mandatory legal provisions.

6. Rights related to the processing of personal data

You have the following rights related to the processing of your personal data:

- right to withdraw consent to the processing of data withdrawal of consent to the processing of personal data is equivalent to withdrawal from the recruitment procedure for the project. - 2) right to access your personal data;
- 3) right to demand the rectification of your personal data that is inaccurate and right to have incomplete personal data completed;
- 4) right to obtain from the controller the erasure of personal data, especially if you withdraw your consent for processing, if there is no other legal basis for processing;
- 5) the right to request restriction of processing your personal data;
- 6) the right not to be subject to decisions based solely on automated processing including profiling;
- 7) right to lodge a complaint with the supervisory authority in charge of the personal data protection, namely the President of the Personal Data Protection Office.
