Your personal data shall not be disclosed to third parties.

7. You shall have the following rights to your personal data processing:

- 3. right to request the removal of your personal data, in particular in the case of withdrawal of your consent for processing, when there are no other legal grounds for personal data processing;
- 4. right to request the restriction in the processing of your personal data;
