3. Purpose and legal basis for processing

The legal basis for the processing of personal data is Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation):

- (1) Your consent to the processing of your personal image data for the purpose of documenting events/photographic sessions organised by the University of Silesia in Katowice, including: use, recording, processing, reproduction, archiving, making available to the public, as well as making, storing and using backup copies and publication, also possibly in juxtaposition with images of other people (group photos, films), through any medium, including electronic and printed versions.
- (2) Your consent to the release of personal image data to local, national or foreign media.

4. Retention period of personal data

We will retain your personal image data until you withdraw your consent to the dissemination of your image.

5. Data recipients:

We may share your personal data with third parties and public authorities and bodies authorised to receive it in accordance with applicable law.

6. Rights regarding personal data processing and automated decision making

Your rights in relation to the processing of your personal data are as follows:

1. the right to withdraw your consent to the processing of your data; the withdrawal of your consent shall not affect the lawfulness of the processing carried out on the basis of your consent prior to its withdrawal;

You may withdraw your consent by sending a statement of withdrawal of consent to our postal address or e-mail address:*;

- 2. the right of access to your personal data;
- 3. the right to request the rectification of inaccurate personal data and the completion of incomplete personal data;
- 4. the right to request the erasure of your personal data, in particular in the event of withdrawal of your consent to the processing, where there is no other legal basis for the processing;
- 5. the right to request the restriction of the processing of your personal data;
- 6. the right to object to the processing of your data;
- 7. the right to portability of your personal data;
- 8. the right to lodge a complaint with the supervisory authority for the protection of personal data, i.e. the President of the Office for the Protection of Personal Data;
- 9. that your personal data will not be used for automated decision making, including profiling.
