Cambridge Centre for Animal Rights Law

The Cambridge Centre for Animal Rights Law was started in 2019 as an educational charity with the goal to advance the study of fundamental rights for animals. The Centre has three main pillars: research, teaching, and outreach.

One of the teaching targets of the Centre is for 100 universities to be teaching an Animal Rights Law course in 5 years. In order to reach this goal, the Centre supports Law Lecturers' Workshops to help law lecturers design and teach their own Animal Rights Law courses.

Law Lecturers' Workshop 2023

The next Workshop will be over 5 days (Mon-Fri) from **25 to 29 September 2023** in Katowice in Poland, in collaboration with the Faculty of Law and Administration of the University of Silesia in Katowice.

The Workshop will be given by in English Dr Sean Butler (Fellow, St Edmund's College, Cambridge and Affiliated Lecturer, University of Cambridge, UK) and Dr Raffael Fasel (Affiliated Lecturer, University of Cambridge, UK), who together teach Animal Rights Law as part of the undergraduate Law degree at the University of Cambridge. Drs Butler and Fasel have also written the first textbook on Animal Rights Law.

In the Workshop, Drs Butler and Fasel will share all the course materials from their Cambridge University course, discuss strategies of how to put together an Animal Rights Law syllabus, and look at what readings to include and how to involve students. Participants will develop their own Animal Rights Law course outline during the Workshop.

On completion, participants will receive a certificate confirming successful completion of the course and will join the growing Animal Rights Law Teaching Network – an online community of global Animal Rights Law teachers.

Target group

The Workshop is open to law lecturers, adjunct professors and PhD candidates, who expect to be in a position to offer an Animal Rights Law course on a credit-basis or non-credit basis to students in the near future. Preference will be given to candidates working at universities in Eastern Europe, but applications from other candidates will also be considered.

In your Statement of Interest, please explain what your university affiliation involves, and why you expect to be able to start teaching an animal rights law course within the next 2 years.

The Cambridge Centre for Animal Rights Law and the University of Silesia will cover food and workshop costs during the Workshop. There are a limited number of hardship grants available up to €300 each. Up to 12 participants will be selected for the Workshop.
