- The paper in its final form needs to be submitted to the electronic registration system until 22 April 2024.

Electronic Collection of Papers will be prepared from the papers actively presented by their authors and submitted by their authors via electronic system.

To have your paper published in the Collection of Papers, the following requirements must be met:

- presenting the paper at the conference,
- preparing the paper according to the set template,
- submitting the paper within the set deadline,
- recommendation of the publication of the paper by two assigned reviewers.

Further instructions and detailed conference program will be sent to the conference participants electronically no later than 10 days before the conference is held.
